CONDITIONS. PLEASE READ.

- Cutting and cattle available.
- Consignment forms must be accompanied by original registration papers and a signed transfer OR the Catalog Fee and a photocopy of the registration papers. **THE ORIGINAL REGISTRATION PAPERS MUST BE RECEIVED WITHIN 10 DAYS AFTER CONSIGNMENT FORM IS RECEIVED, OR THE HORSE WILL NOT BE CATALOGED.**
- Consignors will be paid within five (5) banking days from day of sale.
- A signed breeder's certificate must accompany all bred mares and mares with foals at their side.
- Thirty-Two Cattle Company and its associates act as agent only on all sales and are not responsible for buyer/seller error or misunderstanding.
- Any defects or bad habits must be called when horse is sold. (Example: Cryptoids, Cribbers, Lameness or Unsoundness, Parrot Mouth, etc.)
- The commission will be eight percent (8%) of the selling price. The consignor will have the privilege to "no sale" (Pass Out) his horse.
- Three generation pedigrees will be printed in the catalog on all horses consigned.
- ONLY HORSES CONSIGNED TO THE SALE WILL BE ALLOWED ON THE SALE GROUNDS.** All horses sold before, during and after the sale will be subject to the 8% sales commission in addition to the catalog fee. **ALL CONSIGNMENTS MUST GO THROUGH THE SALE RING.**
- A \$600 Halter Charge will be applied to every horse that is sold. A new halter is given to the buyer when payment is made.
- Transfer fees for Quarter Horses will be deducted from the seller.
- Individual **NEGATIVE COGGINS TEST** current within 6 months and a **HEALTH SHEET** is required for each horse.
- Upon execution of this contract, Consignor agrees **NOT TO DISPOSE OF THE HORSE BY PRIVATE SALE.** Any horse withdrawn from the sale, for any reason other than infirmity will be assessed a \$500 penalty in addition to the \$250 catalog fee or 8% of the selling price, whichever is greater.
- Mares selling in foal must have a completed and signed breeder's certificate or a letter from the stallion owner stating the breeder's certificate will be issued at foaling.
